Chrysanthemum White Rust

Chrysanthemum white rust (CWR) is caused by the fungal pathogen, Puccinia horiana. Unlike many rust diseases, CWR is a monoecious rust, meaning the pathogen completes its life cycle on only one host species. Host species include chrvsanthemums and other closely related species, like Nippon daisy. CWR is a serious disease that can cause rapid plant decline and substantial loss, as well as, the potential to devastate the chrysanthemum nursery industry. CWR is a state and federal quarantine significant pest.

The pathogen is native to eastern Asia, and is considered widespread in many parts of the world, including Europe, Africa, Australia, and South America. Although the United States has had many localized outbreaks, it is not considered to be established. This is most likely due to the level of state and federal guarantines and regulations employed to mitigate the threat. In the fall of 2013, CWR was officially confirmed for the first time in West Virginia. The West Virginia Department of Agriculture responded with appropriate regulatory actions designed to eradicate and minimize the potential for spread. The regulatory actions taken consisted of quarantine, destruction of diseased plants, sanitation, and fungicide treatments.

The first symptom of chrysanthemum white rust is depressed, yellow spots on the

upper surface of the leaves that will later turn brown. On the undersurface of the leaf directly below the yellow spot, the fungus produces a spore forming pustule. This pustule will initially be either pink or salmon in color and turn white with maturity.



Pustules may develop on any green tissue. While many pests may cause yellowing on the upper leaf surface, the presence of the pustule on the underside of the leaf is diagnostic for CWR in the field. Laboratory analysis of the spores must be performed to confirm the pathogen.

The disease can spread rapidly by basidiospores released from pustules at times of high relative humidity and favorable temperatures that can lead to epidemic

levels. The pathogen favors temperatures of approximately 40-75°F, with optimum temperatures in the mid 60s for infection. Free standing moisture is required for the spores to germinate on the leaf surface and cause infection. Sources of this moisture may be attained from dew, fog, rain, or irrigation. Unfortunately, these favorable conditions are often found in early fall or in greenhouses at any time of year. A latency period of 5 days up to 2 weeks is usually seen between infection and symptom development. Symptom expression may be delayed further during hot, dry weather. Spores are relatively fragile and dry out quickly when environmental conditions are not favorable. The fungus can't survive long outside of host tissue.

There are protectant and systemic fungicides available that are labeled for use against CWR. Protectant fungicides like the ones containing the active ingredients chlorothalonil or mancozeb are only effective to protect from new infections and will not provide any control after infection or symptom development. Systemic fungicides, such as those that contain the active ingredient myclobutanil, will move within the plant. While these fungicides are also of limited value on plant material expressing symptoms, they can provide control during the latency period after infection.

October 5-11, 2014 is National 4-H Week and all counties throughout the state will be celebrating the 4-H youth and adult volunteer leaders who have made an impact on the community and who are stepping up to the challenges of a complex and changing world.

Also during National 4-H Week, hundreds of thousands of youth from across the state and nation will complete a single, innovative experiment on 4-H National Youth Science Day, which will be held on October 8, 2014. This event, which takes place in urban, suburban and rural communities all across the country seeks to spark an early youth interest and leadership in science, technology, engineering and math (STEM) careers in an effort keep America competitive in those fields.

This year, the National Science Experiment will be – Rockets to the Rescue! Designed by the University of Arizona Extension, the year's set of activities explores the field of aerospace engineering. In light of the recent natural disasters such as Typhoon Haiyan, National 4-H Council is asking youth to design and build an aerodynamic food transportation device that can deliver a payload of

nutritious food to disaster victims. Youth will learn engineering concepts, develop math skills, learn about nutrition and help solve a relevant, global issue. 4-H National Youth Science Day is the premier national rallying event for year-round 4-H STEM programming, bringing together youth, volunteers and educators from the nation's 109 land-grant colleges and universities to simultaneously complete the National Science Experiment.

The Wayne County Senior 4-H Shooting Sports Shotgun Team represented West Virginia for the first time at the National 4-H Shooting Sports Invitational, June 24-29, 2014 in Grand Island, Nebraska. New Producer Association Promoting Maple Syrup in the Mountain State

Maple syrup producers are forming an organization to help bring attention to the industry in West Virginia. The WV Maple Producers Association bylaws are being finalized and the group is seeking more members and a higher profile for Mountain State maple syrup.

"The first purpose is for people to have knowledge that we can make maple syrup here," said Mt. Storm resident Robert Reed. "We have 25 people so far and we're trying to get more. We know there are more people in the state."

Another goal is to increase marketing of WV Grown maple syrup.

"We've got to get people to understand – we can do this. I've tasted syrup from lots of states, and I'll admit I'm biased, but I think we've got the best," Reed said.

And it's yet another agricultural product that can use existing resources to contribute to the state's economy. A 40-gallon barrel of finished syrup can bring as much as \$1,100, Reed noted.

The recently passed Farm Bill contains provisions referred to as the "tap act" to help maple-producing states with marketing and education programs, and Reed wants West

Always read and follow the label of any pesticide before application! The best control for CWR is exclusion. Always buy cuttings from reputable nurseries that are in compliance with all state and federal agricultural laws. Due to the fragile conditions required by the fungus for infection, cultural practices that reduce humidity and free standing moisture on leaves will reduce severity of disease. These may include, but are not limited to, the use of fans/vents in greenhouses, avoiding overhead irrigation, ensuring proper sun exposure, and proper plant spacing. Regular inspection of chrysanthemums is also critical to identify disease as early as possible. Please report all suspected chrysanthemum white rust to the West Virginia Department of Agriculture, Plant Industries Division at (304) 558-2212.



Virginia to get its fair share.

He noted that most people associate maple syrup with states further north than West Virginia, such as Maine and Vermont. However, West Virginia's climate and topography combine to create good conditions for maple syrup production - not to mention the fact that the Sugar Maple has been the state tree since 1949.

Ideal conditions, Reed says, are nighttime temperatures of 20-30 degrees, abovefreezing daytime temperatures and

lots of sunshine to promote the budding process.

"You have to pay attention to the weather year-round," he said. "When the leaves are on, we want rain and sunshine. From September on, we need lots of sunshine."

While the state has always had a number of people who head to a "sugar camp" in late winter, Reed says numbers dwindled before picking back up in recent years. But the potential is far greater than the current number of producers. The percentage of Red Maple and Sugar Maple is increasing in West Virginia's forests.

WVDA Offering Safe Food Production Class Sept. 12 in Charleston

The West Virginia Department of Agriculture (WVDA) will offer a Good Handling Practices/Good Agricultural Practices (GHP/GAP) class Sept. 12 in Charleston, to help West Virginia food producers protect consumers from food-borne illnesses.

The class will be held at the Guthrie Agricultural Center in Building 2, from 9 a.m. until 5 p.m. Cost of the class is \$25 and includes several handout materials. The class prepares producers for a GHP/GAP audit.

While neither the classes, nor the audits, are required by the state, some wholesalers and institutions require suppliers to have GHP/GAP certification. Commissioner of Agriculture Walt Helmick says the program also gives participants an advantage over producers that don't have GHP/GAP certification.

"A key component to "growing growers" in the state of West Virginia is to increase the marketability of our products. GHP/GAP certification is the first step in taking agriculture in our state to the next level," said Commissioner Helmick. "Although currently voluntary, certification would be extremely beneficial to any grower who would like to enter the wholesale/larger retail market. It is our goal to see West Virginia grown products not only in all our local homes, restaurants and institutions, but across the United States and beyond. GHP/GAP certification can help us achieve that goal."

Jefferson County's Protected Farmland Expands to 4,028 acres with 40th Farm

Jefferson County added another 76.5 acres of protected farmland to more than 3,950 acres currently dedicated for agricultural use with the recent \$290,640.00 bargain sale purchase of an agricultural conservation easement for the Circle N Farm in the Charles Town District. The USDA Natural Resources Conservation Service (NRCS) and the Jefferson County Farmland Protection Board provided matching funds for the purchase. The Land Trust of the Eastern Panhandle is the co-holder of the easement.

The property is owned by William and Deloris Nicewarner. It is the fortieth farm in the county permanently preserved through the Jefferson County Farmland Protection Program. More than 93% of the land includes prime and statewide important agricultural soils. The farm supports grain crops, hay production and beef cattle.

Between 2007 and 2012, the number of farms in Jefferson County decreased from 546 to 501, representing a loss of 5,126 acres, according to the 2012 US Department of Agriculture Census.

"It has never been more important to preserve farms and sustain our agricultural heritage if we are to remain a viable agricultural economy," stated County Commissioner Jane Tabb. "The Farmland Protection Program enables us to support our local farmers and protect our quality of life." Mr. Nicewarner said, "My father bought this land in 1944 in case the Depression happened again, so we could feed ourselves. Mother always wanted it to stay in the family. Our three sons help us with the farm. We'll use some of the funds we receive to upgrade the farm, and fix up the buildings."

Mrs. Nicewarner said, "Bill's mother would be tickled to death that we are protecting the farm. Development is growing up around us too much, and we want to keep the little bit we have for our sons, grandchildren and great grandchildren."

"Protecting our county's farmland goes hand in hand with protecting the quality of life in Jefferson County," said Elizabeth Wheeler, Board Administrator. "Local farms provide us with healthy food, support the economy, and protect water supplies, wildlife habitat and the scenic and historical landscapes that make Jefferson County such a beautiful place to live and visit."

This is the 40th conservation easement completed by the Jefferson County Farmland Protection Board. To date, the Board has protected 4,028 acres of farmland in Jefferson County. The Board recently approved the application of another 434 acres to NRCS for matching funds in 2015.

About the Jefferson County Farmland Protection Board

The Jefferson County Farmland Protection Board was established under a state law passed in 2000 that allows West Virginia counties to levy a transfer tax on real estate to purchase development rights from landowners who wish to protect their land for agricultural purposes.

An agricultural conservation easement is a voluntary, legally recorded deed restriction that is placed on a specific property used for agricultural production. It is a flexible legal tool that enables landowners to permanently protect the agricultural, natural, scenic and historic values of their property from development and subdivision. The county certifies the development values for each farm based on an independent appraisal conducted by licensed appraisers and reviews by federal staff appraisers. Property owners retain full use and ownership of the land. Because an easement is perpetual, it is transferred with the property when the property is sold, thereby forever protecting it.
