SMALL PRODUCER - NO FEE REQUIRED**

§61-7A-2 (WV Marketing of Eggs Rule) The Department shall issue an Egg Distributor Permit to every person distributing eggs in West Virginia. The certificate shall expire on the thirtieth (30th) day of June following date of issue.

§61-7A-3 (WV Marketing of Eggs Rule) **A small producer is any person marketing one hundred fifty (150) dozen of eggs or less per week of his or her own production. A small producer is exempt from paying permit or inspection fees as set forth in Section 2 of this rule. Small producers will label their cartons according to legislative rule.**
