

Where do I take my pesticide exam?

Examinations are given at the following locations.

Note: This is a tentative schedule. Exam dates may vary. Please phone the WVDA/Pesticides at (304) 558-2209 to confirm examination dates.

Charleston: - 1st Monday of each month (304-558-2209) 281 Gus R. Douglass Ln./25312
I-77 north take exit 106 (Edens Fork). Turn left off exit ramp onto Edens Fork Road. Go
2.2 miles until you come to the intersection of Rt. 21 and Edens Fork Road. Turn right onto
Rt. 21 and travel 3.3 miles until you come to a blue sign on the left side of the road indicating Gus R. Douglass
Agricultural Center. (Fishers Branch Road). At top of hill turn left into the
Gus R. Douglass Complex. Go to Building 7.

I-77 south take Tuppers Creek exit. Turn right off exit ramp onto Tuppers Creek Road. Go until you come to the intersection of Rt. 21 and Tuppers Creek Road. Turn left onto Rt. 21 and travel until you come to a sign on the right side of the road indicating <u>Gus R. Douglass Agricultural Center</u>. (Fishers Branch Road). At the top of the hill turn left into the Gus R. Douglass Complex. Go to Building 7.

Parkersburg: - 2nd Friday of each month (304-424-3414) 1412 Blizzard Dr./26101
From I-77: Take US Rt. 50. Take the Division St. exit. Turn left onto Division St. Pass McDonalds and stay in the left lane through the light. Head up the hill, the office is next door to Pizza Place. Pull behind the dentist office. You will go down a little hill and there is a back entrance to "basement" office area, which is where the exam is given.

Beckley: - 3rd Tuesday of each month (304-561-8566) 463 Ragland Rd./25801

Take Beckley exit off of I-64 which puts you on Eisenhower Drive. Go through five stoplights on Eisenhower Drive. At the sixth stoplight turn right (will be a CVS and a Walgreens at the road turning into) go one mile after turning, you will see a two story wood building on the left side of the road with sign SOUTHERN SOIL CONSERVATION DISTRICT. Turn left and park in either parking lot. Tests are given on the 1st floor of the building.

Take exit 48 US-19 north Beckley off of I-77. Take WV-16 exit to Bradley north Beckley off of US-19. Turn right onto Robert C. Byrd Drive. Follow Robert C. Byrd (3.4 miles) until you get to Ragland Road on left. Go one mile after turning, you will see a two story wood building on the left side of the road with sign <u>SOUTHERN SOIL CONSERVATION DISTRICT</u>. Turn left and park in either parking lot. Tests are given on the 1st floor of the building. *Note: If traveling north I-77, there may be a toll on US-19.

Inwood: - Last Tuesday of each month (304-229-5828) 145 Pilgrim St./P.O. Box 66/25428 From I-81 take Exit 5. Go east then turn right at the second paved street on your right (Pilgrim St.). We will be the first building on the right, across from the W.V. Farmers Market.

Morgantown: - 3rd Friday of each month (304-285-3133) 3453 University Ave./Star City, WV 26505 I-79 North: Take exit 155, turn right onto Chaplin Rd. Merge onto Monongahela Blvd. Cross the river and turn left onto Boyers Ave. at stoplight. Turn right onto University Ave. Travel up the hill, Starcrest Plaza is on the right. The office is the last door on the right of the building.

I-79 South: Take exit 155, turn left onto Chaplin Rd. Merge onto Monongahela Blvd. Cross the river and turn left onto Boyers Ave. at stoplight. Turn right onto University Ave. Travel up the hill, Starcrest Plaza is on the right. The office is the last door on the right of the building.

Milton: - Last Thursday of each month (304-743-5236) 878 Rear Main St./P.O. Box 189/25541 From I-64 east or west – take Milton exit #28 go south to Rt. 60 west. The office is located 0.5 miles on the left in the Division of Forestry District IV office building. This is directly across Rt. 60 from the Perry Morris Square.
