Diversified Livestock Operator at Leading Valley Farm

Bernadette and her husband, John, have had a cow-calf operation on their 165-acre farm at Camden for over 40 years. They also owned and operated the John T. Law Accounting Firm in Weston for 36 years. During that time, and especially tax season, Bernadette was the one who took care of the farm, in addition to working with the accounting firm. She was there to see the calves were being born and making sure they were properly cared for. She assisted the USDA Natural Resources Conservation Service staff when they would come to prepare new techniques with a pond, fence or water trough installation.

Bernadette has served as a Conservation District Supervisor for the West Fork Conservation District for the last 20 years. During this time, she has conveyed to local farmers her enthusiasm and dedication to the world of
