Seed Potato Distribution Report

Pursuant to West Virginia Code 19-16-3: The number, variety and size of containers bought, offered or exposed for sale shall be reported by the person first entering the seed potatoes into West Virginia trade channels on forms provided by the Commissioner. The person first offering seed potatoes for sale with the State of West Virginia shall pay the required fee and shall furnish to his or her customers an invoice bearing the statement "West Virginia Seed Fee Paid." The statement may also be used by wholesale dealers on an arrears basis to accommodate their bookkeeping systems provided the arrears payments shall not be later than the fifteenth day of the following month for the previous reporting period. Any persons having in his or her custody any lot of seed potatoes and who is unable to produce evidence that he or she paid the seed fee is liable for payment of the fee.
