- Tonnage shall be reported as exempt or non-exempt. Exempt is defined as those tonnage fees paid by someone other than yourself. Non-exempt refers to those tonnage fees you are responsible for paying.
- 2.) Fill out the back portion of this form, indicating tonnage by fineness and type.
- 3.) A minimum payment of \$10 is due if the inspection fee is over \$2. If the inspection fee due is \$2 or less, this minimum payment is waived.
- 4.) If the tonnage report is received by the Department of Agriculture after the deadline, a penalty of 10% of the fees due or \$100 (whichever is greater) will be assessed.
- 5.) Return completed form with a check or money order payable to the West Virginia of Agriculture by July 31 or January 31 to avoid the late penalty.

All fees must be paid in U.S. funds drawn from a U.S. bank, unless the registrant includes an additional **\$35** to cover the WV Treasurer's Office handling cost for processing a foreign check.
