Pursuant to West Virginia Code 19-14-9: Each person holding a commercial feed manufacturing permit, a commercial feed distributor permit and every registrant, except persons exclusively distributing or manufacturing pet food or specialty pet food or exclusively distributing or manufacturing commercial feed in packages of ten (10) pounds or less, shall file a semi-annual statement under oath, which includes the number of net tons of commercial feeds and feed ingredients manufactured or first distributed in the State during the preceding six-month period.

If you are required to fill out a report, all commercial feed in packages over ten (10) pounds and bulk distributed in this State must be reported; however, the following are exempt from payment of an inspection fee:

- 1) Commercial feed, if the payment was made by a previous distributor;
- 2.) Commercial formula feeds or commercial feeds manufactured in this State, if the inspection fee was paid on the commercial feed or all the feed ingredients used as ingredients therein.
- 3.) Commercial feeds manufactured in this State which are subsequently used as ingredients in continuing manufacture of commercial feeds in which the end of product is registered
- 4.) Commercial feed supplied to a poultry contract feeder
- 5.) Commercial feed in packages of ten (10) pounds or less
- 6.) Pet food or specialty pet food
- 7.) Commercial feed where the inspection fee was paid during a previous quarter and is offered for sale in the current quarter.

Please calculate commercial feed and/or customer-formula feed on the back of this sheet. Provide totals on the front in order to calculate payment due. Sign and date tonnage form.

Inspection Fee** (\$0.35 per ton)

If the calculated inspection fee is \$2 or less, no fee is due. If the calculated amount is between \$2.01 and \$10 the is fee is \$10. Submit the total amount due if over \$10.

Late Penalty

For all reports postmarked after the 31st of January and July, the late penalty is an additional 10% of the inspection fee (if there is any inspection fee due) or a flat \$100 for those reports with no inspection due.

All fees must be paid in U.S. funds drawn from a U.S. bank, unless the registrant includes an additional \$35 to cover the WV Treasurer's Office handling cost for processing a foreign check.
